Description

Perform theater contracting support situational training; manage theater contracting support; coordinate theater contracting support; prepare contracting team (CT) for deployment; assist with the administration of contracting support integration plans (annex W); prepare for contingency contracting deployment; review requirements packages; conduct contract solicitation process; perform contract administration and management; conduct contingency contract administration services (CCAS); complete contract close outs; establish a regional contracting office/center (RCO/RCC); serves as a Division and/or Corps-level liaison staff NCO for a contracting battalion (CBN) and/or contracting support brigade (CSB), instrumental in performing all three functions of effective operational contract support (OCS) per ATP 4-10.

Army Acquisition Transition Course (AATC)

- You will attend the Army Acquisition Transition Course (AATC) at the Acquisition Center of Excellence (ACoE) located on the University of Alabama, Huntsville campus.
- Commissioned officers must have completed their branch advanced course, must be a Captain (O3) or above, and must have been assessed into the U.S. Army Acquisition Corps with a Functional Area code of 51.
- Non-Commissioned Officers must have been assessed into the 51C MOS and must be a Sergeant (E5) or above.
- Is an onsite course not offered virtual.
- Your Contracting Team will help guide you and prepare for the course.**

NCOs

Must be eligible for reclassification per AR 614-200.

Minimum of a 110 GT Score (NON WAIVERABLE).

Must maintain their deployable status as outlined in AR 40-501 and AR 600-60.

Must submit a DA 4187 signed by a Company Commander or higher.

E5s must be eligible to be promoted to the next rank.

Potential to promote to E8.

Have 5 years retainability.

Officers

Commissioned officers in the U.S. Army Acquisition Corps (AAC) are designated as FA51 officers and will be assigned to 51C area.

The focus group are senior captains who have completed Company Command and have at least 24 undergraduate business hours.

Must maintain their deployable status as outlined in AR 40-501 and AR 600-60.

Have 5 years retainability.

Common Questions

DO I NEED 24 HOURS OF BUSINESS OR A BACHELOR'S DEGREE TO APPLY? No, you do not. However, you will need to complete both your bachelor's degree and 24 business hours within 24 months of assessing as a 51C.

WHAT IS THE HIGHEST RANK I CAN MAKE IN THE TXARNG AS A 51C? Slot availability dependent, NCOs E8 and officers O4.

51C Path

- Accession
 - Complete a provided packet for review
 - Takes 4-6 weeks
- Credentialing (AATC)
 - 9 weeks
- CON DAWIA Certification
 - Complete 12 months of contracting experience via 1 of 3 paths you decide:
 - Evaluate prior contracting experience
 - Placed on ADOS at Camp Mabry USPFO
 - Deploy forward as needed by NGB
 - Take the Contracting Professional exam
 - CON3992 Proctored 3-hour exam
